Frank B. (Burk) Wyatt, II Senior Vice President, General Counsel & Secretary Chief Legal Officer

Frank B. (Burk) Wyatt, II began his career in 1996 at CommScope, a telecommunications equipment provider headquartered in Hickory, North Carolina, as the company's first Chief Legal Officer. In 1997, he helped CommScope spin off as a public company traded on the New York Stock Exchange. In 2011, CommScope became a private company owned by funds affiliated with The Carlyle Group. CommScope completed an IPO in 2013 and is again a publicly traded company on NASDAQ. In addition to being General Counsel, Burk is also responsible for real estate, trade compliance, Environment Health Safety (EHS), Environmental Services Group (ESG), business continuity and product safety and compliance.

Prior to joining CommScope, Burk was an attorney in private practice focusing on technology and intellectual property law in Charlotte, North Carolina with a law firm that merged into Alston & Bird LLP. He commenced his legal career after earning his Juris Doctorate degree from Wake Forest University School of Law in 1987.

Admitted to the North Carolina State Bar, District of Columbia Bar, and United States Supreme Court, Burk is also registered to practice before the United States Patent and Trademark Office. He is a member of the American Corporate Counsel Association, American Society of Corporate Secretaries, and the Institute of Electrical and Electronic Engineers.

He serves on the Board of Directors for the North Carolina Technology Association (Chairman 2018), North Carolina Community College Foundation (term ended), Greater Hickory Classic Champions Tour (PGA) golf tournament (term ended), Piedmont Council of the Boy Scouts of America, YMCA of Catawba County (term ended), and the Catawba County Economic Development Corporation (term ended). He serves on the Board of Trustees for Catawba Valley Medical Center and serves on the Conservancy Board of Deidra Lackey Memorial Park. In 2015, Burk was elected as the Chairman of the Bond Commission for the City of Hickory, North Carolina, which helps develop recommendations on how to improve the community.

Mr. Wyatt was elected for many years by his North Carolina lawyer peers as a "Legal Elite" Attorney-Corporate/Business Law. Burk was named a recipient of the Charlotte Business Journal Corporate Counsel Award, an honor for outstanding legal work and value added to CommScope's bottom line. In 2017, Burk received the Top General Counsel Award by First Chair based in Chicago, IL.

Burk is the Chairman of the General Counsel Advisory Committee for Wake Forest University School of Law and serves on the steering committee for the General Counsel Leadership Network for the Southeastern United States (facilitated by Ernst & Young).

Burk is actively involved with Boy Scouts of America (with whom he achieved the Eagle Scout award) as well as numerous other civic and church endeavors. As a North Carolina State University graduate, he earned his Bachelor of Science degree in Electrical Engineering in 1984. He is originally from High Point, North Carolina, and now resides in Hickory with his wife and three children.
